

EXHIBIT D - ZEUS END-USER LICENSE AGREEMENT - U.S.A. Only

PLEASE READ THIS DOCUMENT CAREFULLY BEFORE USING THE ENCLOSED SOFTWARE. THIS AGREEMENT LICENSES THE ENCLOSED SOFTWARE TO YOU AND CONTAINS WARRANTY AND LIABILITY DISCLAIMERS. BY USING THE SOFTWARE YOU ARE CONFIRMING YOUR ACCEPTANCE OF THE SOFTWARE AND AGREEING TO BECOME BOUND BY THE TERMS OF THIS AGREEMENT. IF YOU DO NOT WISH TO BE SO BOUND, DO NOT USE THE SOFTWARE, AND PROMPTLY RETURN THE ENTIRE PACKAGE INCLUDING ALL DISKS, SOFTWARE, DOCUMENTATION, REGISTRATION CARDS AND COLLATERAL MATERIALS, TO THE PLACE WHERE YOU OBTAINED IT, FOR A FULL REFUND.

1. DEFINITIONS

(a) "Educational Version" means a version of the Zeus Productions Product, so identified, intended for use by students and faculty of educational institutions only.

(b) "Not For Resale (NFR) Version" means a version of the Zeus Productions Product, so identified, intended for review and evaluation purposes only.

(c) "Zeus Software" means the software program included in the enclosed package or electronic archive, and all related updates supplied by Zeus Productions.

(d) "Zeus Product" means the Zeus Software and the related documentation, examples, ReadMe files and multimedia content (such as animation, sound and graphics) and all related updates supplied by Zeus Productions.

(e) "End-User Product" means the output file generated by you that makes use of and/or incorporates the Zeus Software. The End-User Product typically is a Run-Time Projector created with Macromedia Director(TM), such as animations, courseware, presentations, demonstration disks, interactive multimedia material, interactive entertainment products and the like.

(f) "Zeus Run-Time" means the portion of the Zeus Software required in order for the End-User Product to operate on hardware on which the original Zeus Software is not resident. In some cases, the Zeus Run-Time may be materially identical to the Zeus Software itself, or there may be a separate Run-Time version of the Zeus Software specifically for distribution with the End-User Product.

(g) "Zeus Run-Time Distribution" means a product which is published, distributed or delivered in any form for commercial gain (even if distributed for free for promotional purposes) which includes the Zeus Run-Time software. While minor product revisions do not count as separate Run-Time Distributions, major product revisions, sequels and substantially similar editions (such as in an electronic magazine or periodic software sampler) are treated as separate Run-Time Distributions, as are separate projects delivered to third parties for commercial gain, projects distributed to sales forces, and each site or location at which a kiosk-based product is installed.

2. LICENSE

This Agreement allows you to:

(a) Use the Zeus Software on a single computer.

(b) Make one copy of the Zeus Software in machine-readable form solely for backup purposes. You must reproduce on any such copy all copyright notices and any other proprietary legends on the original copy of the Zeus Software.

(c) Make copies of the End-User Product (and the associated Zeus Run-Time) and distribute those copies for use by personnel employed by you. (Note that the Zeus Run-Time may be distributed, but not the main Zeus Software itself). Users of Educational Versions and Not For Resale (NFR) Versions agree that End-User Products shall not be used for, nor shall they be distributed to any party for any commercial use or gain. Educational and NFR Versions are specifically prohibited from being used by programmers or other consultants who charge money for their services.

(d) Certain Zeus Software is licensed with additional rights as set forth in the Supplementary Rights Addendum that may be included in the package for this Zeus Product.

3. SUPPLEMENTARY LICENSES

Certain rights are not granted under this Agreement, but may be available under a separate agreement. If you would like to enter into one of the Supplementary Licenses listed below, please contact Zeus Productions.

(a) Site or Network License

You must enter into a Site License or Network License if you wish to make copies of the Zeus Software for use with additional computers owned by you. This would allow you to install and operate the software on multiple computers simultaneously.

(b) Limited Distribution License

You must enter into a Zeus Run-Time Distribution Agreement if you wish to copy and distribute an End-User Product (and its associated Zeus Run-Time) other than as set forth in Section 2. (If you are a developer who has licensed Zeus Software, and are developing software for a separate Publisher, that Publisher must agree to and sign a Zeus Run-Time Distribution Agreement.) YOU ARE ENTITLED TO DISTRIBUTE NO MORE THAN FIVE (5) ZEUS RUN-TIME DISTRIBUTIONS PER COPY OF THE ZEUS SOFTWARE PURCHASED, AND MUST COMPLY WITH THE ZEUS RUN-TIME DISTRIBUTION AGREEMENT FOR EACH OF THE FIVE DISTRIBUTIONS. ANY PROJECT UNDERTAKEN FOR COMMERCIAL GAIN IS CONSIDERED A RUN-TIME DISTRIBUTION. Zeus Productions reserves the sole right to determine what is considered a Run-Time Distribution of the Zeus Run-Time. If you distribute less than five Zeus Run-Times, you may not resell or otherwise barter the remaining distribution rights.

(c) Larger or unlimited Distribution Licenses are also available that allow for more than five (5) Run-Time Distributions.

4. RESTRICTIONS

You may not make or distribute copies of the Zeus Product, or electronically transfer the Zeus Software from one computer to another or over a network. You may not decompile, reverse engineer, disassemble, or otherwise reduce the Zeus Software to a human-perceivable form. You may not modify, rent, resell for profit, distribute or create derivative works based upon the Zeus Software or any parts thereof. You will not export or reexport, directly or indirectly, the Zeus Product into any country prohibited by the United States Export Administration Act and the regulations thereunder. Education Versions and Not For Resale versions shall not be used for commercial purposes.

5. OWNERSHIP

The foregoing license gives you limited rights to use the Zeus Software. Although you own the disk on which the Zeus Software is recorded you do not become the owner of, and Zeus Productions retains title to, the Zeus Product, and Zeus Run-Times and all copies thereof. All rights not specifically granted in this Agreement, including Federal and International Copyrights are reserved by Zeus Productions.

6. LIMITED WARRANTIES

(a) Zeus warrants that for a period of ninety (90) days from the date of delivery (as evidenced by a copy of your receipt): (i) when used with a recommended hardware and software configuration, the Zeus Software will perform in substantial conformance with the documentation supplied as part of the Zeus Product, and (ii) that the media on which the Zeus Software is furnished, if any, will be free from defects in materials and workmanship under normal use. EXCEPT AS SET FORTH IN THE FOREGOING LIMITED WARRANTY, ZEUS PRODUCTIONS DISCLAIMS ALL OTHER WARRANTIES, EITHER EXPRESS OR IMPLIED, INCLUDING THE WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NONINFRINGEMENT. IF APPLICABLE LAWS IMPLY ANY WARRANTIES WITH RESPECT TO THE ZEUS PRODUCT, ALL SUCH WARRANTIES ARE LIMITED IN DURATION TO NINETY (90) DAYS FROM THE DATE OF DELIVERY. No oral or written information or advice given by Zeus Productions, its dealers, distributors, agents or employees shall create a warranty or in any way increase the scope of this warranty.

(b) SOME STATES TO NOT ALLOW THE EXCLUSION OF IMPLIED WARRANTIES. SO THE ABOVE EXCLUSION MAY NOT APPLY TO YOU. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER LEGAL RIGHTS WHICH VARY FROM STATE TO STATE.

7. EXCLUSIVE REMEDY

Your exclusive remedy under section 6 is to return the Zeus Software to the place where you acquired it, with a copy of your receipt and a description of the problem. Zeus Productions will use reasonable commercial efforts to supply you with a replacement copy of the Zeus Software that substantially conforms to the documentation, provide a replacement for the defective media, or refund to you your purchase price for the Zeus Software at its option. Zeus Productions shall have no responsibility with respect to the Zeus Software that has been altered in any way, if the media has been damaged by accident, abuse or misapplication, or if the nonconformance arises out of use of Zeus Software in conjunction with software not supplied by Zeus Productions.

8. LIMITATIONS OF DAMAGES

(a) ZEUS PRODUCTIONS SHALL NOT BE LIABLE FOR ANY INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES (INCLUDING DAMAGES FOR THE LOSS OF BUSINESS, LOSS OF PROFITS OR THE LIKE) WHETHER BASED ON BREACH OF CONTRACT, TORT (INCLUDING NEGLIGENCE), PRODUCT LIABILITY OR OTHERWISE EVEN IF ZEUS PRODUCTIONS OR ITS REPRESENTATIVES HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES AND EVEN IF A REMEDY SET FORTH HEREIN IS FOUND TO HAVE FAILED ITS ESSENTIAL PURPOSE.

(b) Zeus Productions' total liability to you for actual damages for any case whatsoever will be limited to the greater of \$50 or the amount paid by you for the Zeus Software that caused such damages.

(c) SOME STATES DO NOT ALLOW THE LIMITATION OR THE EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU:

9. BASIS OF BARGAIN

The limited warranty, exclusive remedies and limited liability set forth above are fundamental elements of the basis of the bargain between Zeus Productions and you. Zeus Productions would not be able to provide the Zeus Software on an economic basis without such limitations.

10. GOVERNMENT END USERS

The Zeus Product is "Restricted Computer Software"
